The first order of business was the Conditional Use Application for T Mobile Northeast, LLC. Present to represent the applicant was Mr. Donald Petrosa and Scott Donnelly from Smart Link.

Mr. Petrosa gave a brief overview of the application as submitted and indicated the following:

- The overall height of the existing telephone pole with the antenna will be 59 feet or 58.6 feet.
- The cabinets that will be attached to the existing pole require conditional use approval due to the fact they are considered equipment buildings by definition of the ordinance.
- The maximum height for structures in the E-Business district is thirty five feet. The Zoning ordinance permits antennas to exceed the maximum height by twenty feet. The proposed height requires a conditional use approval due to the fact that the height is exceeded by approximately four feet.
- Although Verizon granted a permit to collocate on their pole, the pole may be a municipal pole that was previously used by the Fire Company, according to Township officials.

- Verizon will enter into a licensing franchise agreement with the Township for use of the right of way and municipal pole.
- The equipment cabinets mounted to the utility pole do not need to meet setback requirements due to the fact that the proposed installation is in the right of way.

Bill Cervino's comments and concerns:

• The Zoning issues listed in the engineer's report will be reviewed with the Township Solicitor.
